### Porter County Revenue Bond Project Fund - 4801-000-0068

Additional \$4.5 Million to 31200 Consultants. Reason: Allocation for Capital Improvement Projects

Additional \$24 Million to 39500 Contractual Services. Reason: Allocation for Capital Improvement Projects.

Mr. Bozak, First up this evening we have the Commissioners the Porter County Revenue Bond Project fund, welcome Mr. Scott.

Mr. Whitten, To get the discussion going here Mr. Chairman I'll go ahead and make the motion on the two additionals the \$4.5 million and the \$24 million.

Mr. Rivas, Second.

Mr. Bozak, We've got a first and second, is there any discussion?

Mr. Whitten, We are going to spend some money, right big Scottie?

County Attorney Scott McClure, We are, we are...we have the North County Court House is under contract for the design. The Expo Center is under contract for the design. The Valpo Court House is under contract for the design and the outbuilding in Portage is under contract for design.

Mr. Whitten, So refresh my memory, which of those is the first for ground breaking?

County Attorney Scott McClure, The first will probably be the exterior of the Valpo Court House, will be the first thing going. That will be the first thing bid for the exterior tuck pointing and windows will be the first thing that you see. Then I think at this point the order would be the outbuilding at the Portage Campus and then probably shortly thereafter will be Expo Center.

Mr. Whitten, Gotcha.

County Attorney Scott McClure, Because I think Expo and the Portage Court House will be somewhere around the same time.

Mr. Whitten, What's the timeline on that, do you know for the ground breaking on that? Do you know, if you don't know you don't know...

County Attorney Scott McClure, Well the Expo will be right after the Fair ends.

Mr. Whitten, When is the time for that?

County Attorney Scott McClure, The ground breaking will be right then...I mean right as...the way it's planned right now is for the bid package and the construction to begin...

Mr. Whitten, End of July? I mean I'm just looking for...

County Attorney Scott McClure, Yeah, I mean I can't remember is the Fair is in the end of July or the beginning of August.

Ms. Graham, It is the end of July...

County Attorney Scott McClure, It is literally that next week, I believe that's the goal for that to begin.

Mr. Rivas, You are looking for Portage the outbuilding probably not till late summer then is that why your...?

County Attorney Scott McClure, No that's...Portage will be in phases, but the parking lot and that outbuilding will probably be the first to get ground broke on.

Mr. Bozak, Are you doing work inside the Portage Court House still at all or no?

County Attorney Scott McClure, Oh...not only is there an addition but the entire thing is being remodeled. And then on the phasing of that it will be the addition will go first and the outbuilding will go first and so that way we can move people around to then go remodel what needs to happen in the rest of the building.

Mr. Rivas, A lot of work, it will keep you busy.

County Attorney Scott McClure, Busy.

Mr. Bozak, How's out front coming is that almost done?

County Attorney Scott McClure, The front I believe could be open tomorrow.

Mr. Bozak, Wow.

Ms. Graham, Really

County Attorney Scott McClure, Right now they're just waiting on the ADA switch at the door to be installed and then I believe it could be open for the public and then we will just be waiting for Spring to officially get here to do the landscaping. All the railings are up and everything else like that so it will be down to landscaping at that point so it's not...that's within a week no matter what.

Mr. Bozak, That good news.

Mr. Whitten, That's great.

Ms. Graham, Wow.

Mr. Rivas, That \$4.5 million to Consultants...why so much to consultants?

County Attorney Scott McClure, That's all the design contracts.

Mr. Rivas, That's everything to design contracts?

County Attorney Scott McClure, Yes that's the ... yeah that's the design contracts.

Mr. Rivas, Ok.

Mr. Jessen, You know Scott, for the benefit of the Council is there a time line that is printed somewhere on the different projects and approximate start dates?

County Attorney Scott McClure, Yeah, what were hoping to do in the next...either your next meeting or the meeting after that, have everything finalized to a point where we can bring Skillman in to show you the budgets, show you the timeline, the timelines from not only the designs are supposed to be completed to when they are being bid, to when we're we are awarding to when groundbreaking are. That's exactly what's happening right now is getting that information put together and then we are planning on bring it to the Council and basically giving you guys all copies of what's happening.

Mr. Jessen, Perfect.

Mr. Larson, I'd just like to go back to where Jeremy was at, because I know that we looked at the other Consultant fee and that's about ten percent and we're looking at almost twenty percent of those overall projects in Consultant fees. Is there something behind that...that we're missing? Is there...

County Attorney Scott McClure, Well to be...this original allocation to be honest with you I don't intend on spending all of it this year so I didn't have all the hard numbers when I put these numbers together, so these are broad allocations. The design contracts have been coming in at around ten percent...seven to eleven percents is what they have been coming in at, but that's on the design itself. And then I also have the Construction Management portion that I can either call Consultants or I can call it Contractual.

Mr. Larson, Right.

County Attorney Scott McClure, But those are really the two driving forces behind that number.

Mr. Larson, Yeah, I just didn't want to scare people with that big figure because I know that those are typically ten to twelve...

County Attorney Scott McClure, You also have to remember that within this number there is the three Bridge projects and those Bridge projects are a little bit more design heavy. But then they are on the rest of the Capital Improvement Plan so

to speak, so within that are three bridges being designed beyond Portage, Valpo, Expo, etcetera.

Mr. Bozak, Where are we at with those?

County Attorney Scott McClure, Those are all underway and being designed and we have actually paid some invoices on those already.

Mr. Bozak, Wonderful.

Mr. Whitten, Awesome, hey right on man thanks.

Mr. Bozak, Anyone else have any questions, alright roll call please?

Storm Water Director Robert Thompson, Yes.

County Attorney Scott McClure, No.

Mr. Rivas, No?

County Attorney Scott McClure, No, that's part RDC.

Storm Water Director Robert Thompson, Now were you talking about...

County Attorney Scott McClure, You are talking about 700 right?

Mr. Rivas, and Willowcreek.

Ms. Graham, For Willowcreek...

Mr. Rivas, Willowcreek Storm Water partnership.

Storm Water Director Robert Thompson, Oh Willowcreek Road...

County Attorney Scott McClure, Yes.

Storm Water Director Robert Thompson, Yes this is part of it.

County Attorney Scott McClure, That's correct.

Mr. Rivas, And that's ok everything is "A-ok"?

Storm Water Director Robert Thompson, We're waiting for Portage...

County Attorney Scott McClure, It's moving...

Storm Water Director Robert Thompson, Yeah...to do a Land Acquisition and then we are going to be doing Construction bidding. The County is going to be overseeing the construction on it.

Mr. Rivas, So that's all worked out just fine then?

County Attorney Scott McClure, We're waiting for Portage to acquire the land.

Storm Water Director Robert Thompson, Yes.

Mr. Bozak, Do you know where they are at in that process? Will it be soon or you don't have any clue?

Storm Water Director Robert Thompson, Do not know.

Mr. Bozak, Ok.

Ms. Graham, Is the water starting to go down in the south part of the County?

Storm Water Director Robert Thompson, Yes, but not fast enough.

Ms. Graham, Thank God.

Mr. Larson, There are quite a few flooded fields down there.

Storm Water Director Robert Thompson, Yeah, we had a number of breaches on the Kankakee River. As a matter of fact we've got...

Ms. Graham, I heard there was two.

Storm Water Director Robert Thompson, It came out at Dunn's Bridge area, Hinesburg Ditch came out on the east side. We are currently have crews where we're

having time and material to get back in to fix all that and one of the big things we have problems with the Kankakee River is getting access...getting access. So we are making access in a maintenance road, so that way in the future we...

Ms. Graham, Very good.

Storm Water Director Robert Thompson, can get in there.

Mr. Larson, You guys have moved a long ways along on that it looks really good down there from what I could see.

Storm Water Director Robert Thompson, Yeah, we had a breach at 250 West and not necessarily a breach over at 625 West by Marti's Landing but the ditches got back up so much that the Breyfogle Ditch came out and flooded the area's going into the Kankakee River. We did...Mike Novotney our County Engineer was up in a helicopter with the EMA Director thanks to the Lake County Sheriff's and flew the whole thing. What can you say the DNR and FEMA mapped out the flood plains really well because that exactly where all the...

Ms. Graham, That where it was?

Storm Water Director Robert Thompson, water was.

Ms. Graham, So when you are talking about access, you are talking about maybe fisherman?

Storm Water Director Robert Thompson, No I mean...

Ms. Graham, Way down the line?

Storm Water Director Robert Thompson, Trying to actually get access into the Kankakee River banks and we have an easement...

Mr. Whitten, Are you thinking about throwing a pole in down there?

Ms. Graham, Well you never know.

Mr. Whitten, You've been known to throw a pole or two in the water.

Storm Water Director Robert Thompson, We have a 75 ft easement from the top of the bank down there on the Kankakee River, but it's getting to that easement and working up and down that's where we struggle. And we are trying to...I mean this...

Mr. Larson, So what you are doing Bob and I don't think that they can visualize it, but you are actually putting a road bed on top of the bank.

Storm Water Director Robert Thompson, Right, we are actually putting a road bed on top.

Mr. Whitten, For the record I actually visualized it.

Mr. Larson, That's good.

(Laughter)

Mr. Bozak, When the Commissioners declared a state of emergency have you guys heard anything further on that? Or are you getting any funding?

Storm Water Director Robert Thompson, I know that Mike Novotney is working is working with Lance Bella on a number of those issues. I myself is working on some of the cost that we had. We had a Bridge fail because of the event...

Ms. Graham, Which Bridge is that?

Mr. Bozak, I was hoping that they would pay for it that's why I asked.

Storm Water Director Robert Thompson, Yeah, the Bridge that is on 50 West.

Ms. Graham, Oh, ok.

Storm Water Director Robert Thompson, Between 600 South and State Road 8.

Ms. Graham, Ok.

Storm Water Director Robert Thompson, It's a gravel road I guess if we had to be thankful for a Bridge failing it was on a road with very little travel. But still we had a Bridge fail we had to close it and ended up closing the road down too. We're monitoring a couple of other bridges and one of the things that we are noticing right now is because of this effect some of the failures are just now starting to show up. We've had a number of sinkholes develop because of failed infrastructure and subdivisions that are along the roads and we are just now starting to see a number of these sinkholes. They had one that was just reported today that was quite large that started to cave-in a subdivision road.

Ms. Graham, Oh.

Mr. Bozak, Geez.

Mr. Whitten, Wow.

Mr. Larson, We've applied for some funding? Or we are applying for some funding to help alongside what we are going to invest in that correct?

Storm Water Director Robert Thompson, Part of that is that we are accumulating all the costs with this that's going along with this and getting this to Lance Bella. I know Mike and Lance are coordinating on that to apply for Federal Emergency dollars...yes.

Mr. Larson, Ok.

Mr. Rivas, I think back to Contractual Services, how soon do you think we are going to start tearing up some roads in South Haven to get in there?

Storm Water Director Robert Thompson, Fall.

Mr. Rivas, Fall?

Storm Water Director Robert Thompson, That is what we are hoping, right now we have...we're starting to sit down with all of the design consultants and on one of the agendas I saw that there's some possibility of doing some work in the Fall. Now this is an estimate that we are seeing right now, we are going to know more probably within the next couple months.

Mr. Bozak, Jeremy how was the flooding in that area is it bad?

Mr. Rivas, Yeah it's still an issue, yes absolutely.

Mr. Bozak, Is it bad this last one?

Mr. Whitten, Yeah.

Storm Water Director Robert Thompson, Yeah they have had a number of road closed.

Mr. Rivas, Yep.

Storm Water Director Robert Thompson, It went down fairly quick but they still had to close a number of roads.

Mr. Bozak, So that this money that we are putting in there hopefully next year this will not be a problem? Is this...I mean we are still going to have little problems it's not going to fix it all?

County Attorney Scott McClure, South Haven is going to be a five (5) year process.

Mr. Bozak, Ok thank you.

Storm Water Director Robert Thompson, Yes it is, it is no doubt.

County Attorney Scott McClure, Where every year there will be projects this is just the first five projects.

Mr. Bozak, Ok thank you.

Storm Water Director Robert Thompson, Right because as soon as we finish these first five projects we're going to letting out three or four...it's phased. So as Scott said it is definitely going to be a five year process.

Mr. Bozak, Thank you.

Mr. Whitten, Great news.

Ms. Graham, Yes it is.

Mr. Bozak, Anyone else have any questions?

County Attorney Scott McClure, You can't tear South Have up all at once that's the problem.

Health Department Connie Rudd, Yes we have a two Antabuse nurses...we have actually four Antabuse nurses and Security. There was one Antabuse nurse and one Security person at each office. We have a Portage office and a Valparaiso office at every Antabuse Clinic Monday, Wednesday and Friday. Antabuse is even in session even when there are Holidays, even when there are building closed and the Staff is there at 5:00 a.m. in the morning and they leave at 8:00 a.m. and at night they clock in at 4:00 p.m. and don't leave there till 7:00 p.m. so their day is separated. So we actually have not had a raise since the Health Department took over the collection responsibility in 2014 they hadn't had a raise. And when we looked at this program we...kind of the format has been there since 1991 when the program was started. So we looked at that and we wanted to...whoops. We looked at that and we just wanted to upgrade and restructure and that's why we looked at that and another thing that they...it was never built in by Adult Probation on those Holidays there was never any shift differential and we thought maybe it would be nice if you were asking people to come in on July 4th and Labor Day or whatever Holiday it is that we should give them a little bit of shift differential, that's why the up to and the range is so...

Mr. Bozak, Now I'm just curious...

Health Department Connie Rudd, Sure

Mr. Bozak, why wasn't this addressed during the Budget season last year?

Health Department Connie Rudd, Well we did...we started looking at it you know earlier this year and the reason why we are coming to you now is because we have to go before the Board...the Health Board to get the approval of anything that we change as far as salaries. So that's why we just had our first meeting of the year March 6th?

Health Department Keith Letta, Right.

Health Department Connie Rudd, So I guess we come before you with an approval from our Health Board for this proposal.

Mr. Bozak, And we would prefer to tackle these during Budget season which is why I was asking.

Health Department Connie Rudd, We totally understand that, we try not to do that we always try to play by the rules and I think that you probably see that and know that but...

Mr. Bozak, Yes.

Health Department Connie Rudd, Now Dan I saw that face.

### Soil and Water Conservation

• Presentation on 65th Annual Report.

Mr. Bozak, Next up we have our Soil and Water Conservation presenting the 65th Annual Report, welcome.

SWCD Michelle Benson, Thank you I just wanted to share our annual report with you, Joy kindly put a copy in all of your folders. Primarily I wanted to point out our new logo because last fall we came to you asking for a few more dollars in our 2018 Budget which you graciously allocated and that evening Don from the IT department was in the audience and the next day I got a call from him offering the services of the Porter County IT Department in designing our logo. So that save us about \$500 dollars and \$500 dollars might not seem but we have a saying in our office when you mine the pennies you don't have to worry so much about the dollars. And so we are very proud of the work that we have been doing and certainly would welcome any questions that you have about our annual report. There's more financially information available on the Indiana Gateway site if you access that there is a complete financial report or you can just contact our office I'll be happy to send the information that you need. We are really extremely proud of our new train study that's in its second year. We're getting tremendous support from the National Park Service and also the United States Geological Survey.

Ms. Graham, That's for the north part of the county?

SWCD Michelle Benson, Correct and the Little Cal Watershed.

Ms. Graham, Is there any plans for you to move?

SWCD Michelle Benson, We're hoping, the primary reason that we haven't done that is because of funding and the National Park Service is able to cover laboratory in their jurisdiction, but not in the Kankakee River Watershed because that's out of their service area.

Ms. Graham, Not in their area, ok.

Mr. Whitten, For the benefit of Larson and Rivas I appreciate you putting a lot of pictures in there.

Mr. Larson, Yeah thanks.

SWCD Michelle Benson, Well you know that's kind of the way it is folks don't pay much attention to the written word anymore so we try to put a lot of photographs.

Mr. Larson, I see you have got to him first.

Mr. Bozak, We get your updates every quarter...

SWCD Michelle Benson, Yes.

Mr. Bozak, And they appreciate you keeping us updated...

SWCD Michelle Benson, Right.

Mr. Bozak, and giving us the information...

SWCD Michelle Benson, Sure.

Mr. Bozak, and the meeting times and places, I know some of us are not always able to make them but we appreciate that.

SWCD Michelle Benson, Oh no we understand that and that's why I am here tonight...

Ms. Graham, I was there.

SWCD Michelle Benson, because it's important that we share this and in the past we just haven't really taken the time to do that. We're are excited about a new young man that we recently hired so we hope to have him here to meet at the next meeting or perhaps the May meeting. The wonderful fellow from the Indiana Department of State Agriculture came over to join us. Very talented so we are looking at putting him on some more advance projects.

Mr. Bozak, Wonderful.

SWCD Michelle Benson, We certainly appreciate your support.

Mr. Larson, How does the farming community interact with you guys? Are they very receptive to what you are doing?

SWCD Michelle Benson, Oh exactly our partnership with the Natural Resources Conservation Service allow us to provide cost share to farmers to do cover crop practices, buffer strips and all of this you will notice on that second page helps to reduce sedimentation in ditches, streams and so on which in turn will help reduce flooding when you have a situation with too much rainfall. Now of course the last situation was a little bit extreme...

Ms. Graham, Yeah.

SWCD Michelle Benson, There is not much anybody could do about that. But the whole goal is to reduce that sediment in the stream, ditches and so on.

Mr. Larson, I just know that they have had some conversation about the amount of nitrogen that they are putting in the soil...

SWCD Michelle Benson, Yeah.

Mr. Larson, Fertilization problems...

SWCD Michelle Benson, Yes.

Mr. Larson, and over fertilization and algae growth so I just am really interested in what you guys are doing.

SWCD Michelle Benson, Absolutely and that's what this East Branch Little Cal study is all about. Our Board is extremely proactive you might not be familiar with them but they're considered unpaid employees by the State Board of Accounts.

Mr. Whitten, Yes.

SWCD Michelle Benson, They are Public Officials they do swear out a Oath of Office and so they were actually the ones that instituted the study nobody came to us they went looking for assistance. We had folks come in from Purdue...oh and different Universities and places we just couldn't find anybody to help us, because it's an expensive study to undertake.

Ms. Graham, Yes.

SWCD Michelle Benson, And then all the sudden we were fortunate enough to have the State Department of Agriculture National Parks Services offer their services and they in-turn were pretty eager to work with us because they don't have that relationship with farmers that we do. So it's been wonderful because they are able to provide so much that we're not and USGS has taken that to another level this year with the E-coli test. And we have the results of those studies and we'll be certainly glad to forward those to you.

Mr. Larson, Thank you.

SWCD Michelle Benson, Just send me an email or give me a call we'll get you whatever you need.

Mr. Larson, Thanks

SWCD Michelle Benson, Your welcome.

Ms. Graham, That's great.

Mr. Whitten, Thank you very much.

Mr. Bozak, Thank you very much.

Mr. Rivas, Mr. President I don't mean to go back a little bit but in terms of your...I was just glancing back a little bit through your little synopsis. The Governor he has to agree to declare portions of Porter County a...

Mr. Jessen, Which he has.

Public Safety Director Michael Brickner, Actually (inaudible) goes to...

Mr. Whitten, Ah that does it we're sunk.

## (Laughter)

Mr. Rivas, He just passes it along?

Mr. Bozak, Hey I know him I just give him a call.

Mr. Rivas, He just passes it along? He doesn't have to declare...

Mr. Whitten, Will he twitter us back Trump?

Mr. Bozak, I think it's called tweet.

## (Laughter)

Public Safety Director Michael Brickner, That I can't answer there usually a process as I get more information what I'll do is I'll just let the Council know. Because

we're in constant contact with our District 1 representative and she's really kind of our go between. So if we get any information, hopefully if we hear something soon we are going to get together first to see if we qualify for some FEMA dollars.

Mr. Larson, Well we did make it under the deadline right Mike for the declaration because the Commissioners had to declare it first right? That was the process?

Public Safety Director Michael Brickner, I'm sorry?

Mr. Larson, That we did make under the declaration right?

Public Safety Director Michael Brickner, Yes we did.

Mr. Larson, Ok.

Public Safety Director Michael Brickner, Yeah everything is in...everything on our end is in and now we're just kind of waiting and see.

Mr. Rivas, I just thought that the Governor declaring certain areas in himself a disaster area. I just didn't know if that part of it that he had to do it but you are saying no he just passes it along.

Public Safety Director Michael Brickner, From what I understand that's part of the process that he takes it to the President himself and it seems to be kind of what we are waiting for now.

Mr. Rivas, Yeah.

Mr. Jessen, My impression is that the State has declared Porter County as a Disaster Area.

Mr. Bozak, The State did or did not?

Mr. Jessen, Did.

Mr. Larson, Did.

Mr. Bozak, Well we know a guy, where is Pence tell him to get our back.

Mr. Rivas, Well it might be awhile because I think Trump has got a stormy situation himself.

Mr. Bozak, Hey, hey, hey.

Mr. Whitten, Jeremy...nicely played though.

(Laughter)

Mr. Bozak, Any other questions?

Public Safety Director Michael Brickner, I will let everyone know as soon as I hear something I will pass it on.

Mr. Bozak, Thank you.

And it's clear too that we have had a handle on it from a collaborative standpoint. I mean we are talking about your department, Emergency Managements been aware of and in control of it's also involved the Sheriff's department, Highway department, Stormwater Management it's been an effort where it seems as if the cohesiveness and the collaboration has been the best that I've seen in my experience with County government.

Public Safety Director Michael Brickner, Well I appreciate you saying that and to share with you all of the teamwork which was phenomenal. Stormwater, Highway Department...

Ms. Graham, Your Commissioners went out too.

Public Safety Director Michael Brickner, EMA everybody worked so well together and communicated well. Yeah, I think it's important that the Council to know that the people out there were really working well together and it's stressful. There is a lot of emotion out there...

Mr. Whitten, Sounds like a Council meeting.

Public Safety Director Michael Brickner, I'm sorry?

Mr. Jessen, Yeah there actually getting worked done.

Mr. Whiten, We're working together and having emotions and screaming occasionally.

Public Safety Director Michael Brickner, And then working with the other Counties involved that were affected it was...it got into pretty significant event and we had a lot of players out there at least on the EMA side. Director Bella did an outstanding job but also working with the other departments and it's good for everybody to know that.

Mr. Jessen, Yes absolutely.

Mr. Rivas, Thanks.

Mr. Bozak, Thank you.

Ms. Conover, Doesn't appear that there are still areas that are now manifesting because of that damage?

Public Safety Director Michael Brickner, I'm sorry Karen?
