The Regular meeting of the Porter County Board of Commissioners convened at 10:00 a.m. on Tuesday, May 8, 2018 in the Commissioners' Chambers of the Administration Center.

Those present were: Commissioners Jeff Good, Laura Blaney, Jim Biggs, County Attorney Scott McClure; Administrative Assistant Rhonda Young and Recording Secretary Kathy Merle.

**Call to Order/Pledge**

Com. Good, Good morning, this is the Porter County Board of Commissioners' Special Meeting on Tuesday May 8<sup>th</sup>, 2018. The primary purpose for the meeting is for bid openings for exterior renovation of the Valparaiso Courthouse. So with that we will get started with the bid openings. The first bid opening is Slate Tile Roofing and Sheet Metal Co. at 1703 S. Ironwood Dr., South Bend, Indiana. Their base bid is \$635,230.00 and then we have Alternate Bid #1 for foundation wall waterproofing is \$158,000.00 and that would be an add. The second bid opening is for Berglund Construction, 126 Ventura Dr., they're out of Chesterton and their base bid is \$775,000.00 and their Alternate Bid #1 for foundation wall waterproofing is \$250,000.00 and that would be an add. The third bidder is Gariup Construction 2965 Harrison St., Gary, Indiana. Their base bid is \$547,500.00 and the Alternate #1 for foundation wall waterproofing is and add of \$260,000.00.

Mr. Anderson, That is Bid Category 1, now we're moving on to Bid Category 2.

Com. Good, That is Bid Category 1 that we just announced. This is Bid Category 2. The first bidder is the Lazarro Companies, 5880 Broadway, Merrillville, Indiana. The base bid is \$960,000.00 and no alternates. Last bidder or Package #2 is J.W. Wertz & Son, 1002 Kerr St., South Bend, Indiana their only bid is \$778,000.00. And those are the 2 bids for the second bid package. We will take these under review.

Atty. McClure, Yes we just need a motion to take them under advisement.

Com. Blaney, moved to take the bids under advisement, Com. Biggs, second, motion carried.

Com. Good, The bid will be let at our next Commissioners' meeting.
