Midwest Tile & Interiors – Base Bid \$55,775.00.

Master Tile Inc. – Base Bid \$94,000.00.

Bid Category #6 Mechanical/Plumbing:

Mechanical Concepts Inc. – Base Bid \$76,800.00.

Gatlin Plumbing & Heating - Base Bid \$71,500.00.

Bid Category #7 Electrical:

EMCOR Hyre Electric – Base Bid \$172,435.00. Alternate #2 - \$37,596.00.

Circle R Electric – Base Bid \$183,200.00. Alternate #2 – \$28,900.00.
